## Pacific Swimming Quad Grant Program:

The Quad 3 Grant – Coach Education is ready to launch in October. The applications deadline will be December 31, 2018.

There is an increase in funding this quad. Grant awards will be as follows:

- Clubs between 20 and 100 year-round members will receive \$1,250
- Clubs from 101 to 200 year-round members will receive \$1,500
- Clubs over 200 year-round members will receive \$2,000
- We will recognize multi-site clubs (with over 150 athletes per site)

*Note: clubs must have at least 25 year-round, attached athletes, and cannot be collegiate clubs.*
